Section 3. Rights.

- A. Members shall suffer no impairment of freedom of speech concerning the operations of this organization. Active discussions of organizational affairs shall be encouraged and protected within this organization.
 - B. Members shall have the right to fair and democratic elections at all levels of the organization. This includes due notice of nominations and elections, equal opportunities for competing candidates, and proper election procedures which shall be specifically set forth.
- C. Members shall have an equal right to run and hold office, except those persons set forth in RCW 41.56.030, Paragraph 2, A, B and C; and those employees classified either by State statute or appropriate State regulatory agencies as being a "supervisory employee."
- 13 D. Members shall have the right to a full and clear accounting of all organizational funds. At all levels 14 such accounting shall include, but not be limited to, periodical reports to the membership by 15 appropriate fiscal officers or by independent auditors not otherwise connected with the organization, 16 and a financial audit at least once a year which is made available to all members.
 - E. Members shall have the right to full participation, through discussion and vote, in the decision making processes of the organization and to pertinent information needed for the exercises of this right.

ARTICLE VI **MEETINGS**

Section 1.

General membership meetings of this organization shall be held at least four (4) times annually at a time and 28 place to be fixed by the membership or the Board of Trustees. 29

30 Section 2. 31

Special meetings may be called by the President, the Board of Trustees, or by petition filed with the president 32 and signed by twenty percent (20%) of the members of this organization. 33

Section 3. The President shall provide at least five (5) days notification to all members of any meeting called. However, 36 said five (5) days' notice may be waived by the Board of Trustees provided that every reasonable effort is 37 employed to notify the membership of the meeting. 38

Section 4. 40

- At any meeting of the membership of this organization, each member present shall be entitled to one (1) vote. A 41 member must be present to vote - no proxy vote will be allowed. A minimum of fifteen (15) members must be 42
- present to constitute a quorum before any organization business may be transacted. This is to include, but not 43
- limited to, chapter contract voting. 44

- PSE of Burlington-Edison shall be represented by at least two (2) members of the Board of Trustees or one (1) 47
- board member and a classification representative from the affected classification or the field Representative at 48
- every meeting with District representatives. 49

- ² If a chapter meeting fails to obtain a quorum, the subsequent scheduled meeting shall have a quorum consisting
- of members present, provided that official notification of that second meeting is made at least five (5) days prior
 to such meeting.

11 Section 1.

The business and property of this organization shall be managed by a Board of Trustees, except when the meetings of the organization are in session. All matters affecting the purposes aims and means of

meetings of the organization are in session. All matters affecting the purposes, aims and means of accomplishing the purposes of this organization, not specifically provided for in these Bylaws or by action of the

17 Section 2.

Every even-numbered year, the President, Secretary, and Membership Officer shall be elected for a term of two (2) years. Every odd-numbered year, the Vice President and Treasurer shall be elected for a term of two (2) years. The term of office of all other trustees of this organization shall be for a period of one (1) year from

the date of election. The election of Trustees or Classification Representatives shall be on the first chapter meeting of the school year which will be held in September.

33 Section 3.

Every even-numbered year, the President, Secretary, and Membership Officer shall be elected for a term of two (2) years. Every odd-numbered year, the Vice President and Treasurer shall be elected for a term of two (2) years. The term of office of all other Trustees of this organization shall be for a period of one (1) year from the date of election. The election of Trustees or Classification Representatives shall be on the first chapter meeting of the school year which will be held in September.

40 <u>Section 4.</u>

The Board of Trustees shall hold quarterly meetings and such special meetings as the President shall deem necessary for the competent management of affairs of the organization.

- Each member of the Board of Trustees shall possess one (1) vote on matters coming before the Board. All voting
- at meetings of the Board of Trustees shall be by each member present in person and voting by
- 47 proxy shall not be allowed except that a designated alternate from the same classification may vote in a
- representative's absence. A majority of the members of the Board of Trustees shall constitute a quorum.

2 <u>Section 6.</u>

Any Trustee may be removed from office by a two-thirds (2/3) majority vote of the membership at any regular or special meetings of the membership of the organization. Notice of the proposed removal of the Trustee must be given to the Trustee five (5) days prior to the date of the meeting at which the removal is to be voted upon. Such notice to the Trustee must state the cause of the proposed removal.

8 Section 7.

Unexcused absences from two (2) consecutive meetings of the Board of Trustees shall be due cause for removal
 of the Trustee by the Board of Trustees. Removal of a Board member because of excessive absenteeism shall
 not require a two-thirds (2/3) vote of membership.

13 Section 8.

Any vacancies occurring on the Board of Trustees by reason of death, resignation or removal shall be filled by the remaining Trustees. If the Trustee is an Officer, such selection shall be from the membership at large. All other Trustees' vacancies shall be filled from the classification of which they are representatives. Such an

appointee shall serve during the unexpired term of the Trustee whose position has become vacant.

19 Section 9.

Trustees shall be elected by secret ballot vote, and the balloting shall be conducted so as to afford all members a reasonable opportunity to vote. At least ten (10) days advance notice shall be given the membership prior to the holding of the election.

29 <u>Section 1.</u>

The Board of Trustees shall be chairpersons of the committees.

32 Section 2. President.

The President shall preside at all general meetings of the organization and Board of Trustees' meetings. The

President shall supervise all activities of the organization subject to approval of the Board of Trustees; report periodically to the membership regarding the progress and standing of the organization regarding the President's

The Treasurer shall receive and be accountable for all funds belonging to the organization; pay all obligations incurred by the organization as authorized by the Board of Trustees; and shall render periodic financial reports as required by Article V, Section 2. F. In addition, the Treasurer will arrange for two (2) signatures to be required on all checks. Any chapter expenditure will require the approval of a minimum of two (2) board members.

7 Section 5. Membership Officer.

8 It shall be the duty of the Membership Officer to (including but not limited to):

- Maintain a current and accurate list of members of the chapter in coordination with the membership information section at PSE State Headquarters.
- Ensure that all members are paying dues.
- Ensure that dues paying membership levels are met or exceeded, according to goals adopted by the PSE State Board of Directors.
- Work with designated PSE staff to implement a process for new hires to become full members.
 - Work with PSE staff to recruit, train and develop building and classification reps in every building.
 - Meet with building and classification reps (liaisons) consistent with PSE guidelines.
 - Render periodic membership reports as required by PSE of Washington.
 - Perform such other official functions as the President and Board of Trustees may direct.

A R T I C L E I X MISCELLANEOUS PROVISIONS

26 Section 1.

This Association shall be at all times subject to the provisions of the Articles of Incorporation and Bylaws of the Public School Employees of Washington.

30 Section 2.

Except to the extent specified in the Bylaws, no Officer of this organization shall have the power to act as agent for, or otherwise bind this organization in any way whatsoever. No member or group of members or any other person or persons shall have the power to act on behalf of or otherwise bind the organization except to the extent specifically authorized in writing by the President or Board of Trustees.

36 Section 3.

The latest edition of <u>Robert's Rules of Order</u> shall be the guide in all cases in which they are applicable, and in which they are not inconsistent with the Constitution, Bylaws and special rules of this organization or of the Public School Employees of Washington.

Every Officer and Trustee shall, upon assuming office, subscribe to the obligation of an Officer or Trustee contained in these Bylaws.
