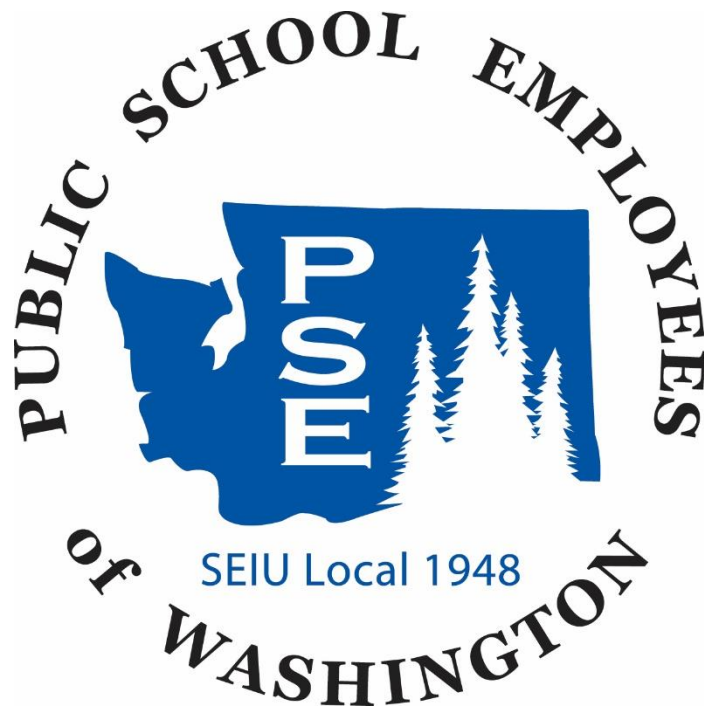

P R E A M B L E

A. NAME

The name of this chapter shall be Public School Employees of Chehalis Transportation and shall be an affiliate of Public School Employees of Washington / SEIU Local 1948 (PSE), a not-for-profit 501(c)5 labor organization operating under the laws of the State of Washington. This organization was chartered by Public School Employees of Washington on November 13, 2002.

B. MISSION - OUR PURPOSE FOR EXISTING

It is the mission of Public School Employees of Chehalis Transportation to work closely with Public School Employees of Washington / SEIU Local 1948 to support the membership through collective bargaining and the protection of those rights, promote educational enrichment opportunities, encourage membership growth, and provide quality leadership while working closely with the state legislature in an effort to enact laws which will represent the best interest of all classified school employees in the State of Washington.

C. VISION - WHAT WE STRIVE TO ACHIEVE

We will provide service of superior quality and value that best meets the needs of our chapter members. We will achieve that purpose through an organization and working environment which attracts the finest people, fully develops and challenges individual talents, encourages our free and spirited collaboration to drive the organization ahead, and maintains PSE's historic principles of integrity and commitment to do the right thing.

Through the successful pursuit of our commitment, we expect our services, programs, and activities to achieve a leadership position in representing all classified employees. As a result, PSE, our members, PSE employees, the school district in which we work, and the community in which we live will grow and prosper.

D. VALUES - THAT WHICH GUIDES OUR DECISIONS, PERFORMANCE, AND CONDUCT

Recognizing the needs of members and PSE staff, we are committed to:

- Striving for excellence and demonstrating pride in our work.
- Having open, honest communications.
- Providing high-quality service.
- Creating a work environment that is enjoyable, rewarding, and comfortable. We want it to be based on trust and concern for the rights and welfare of others.
- Embodying honesty and integrity in our conduct and relationships with others.
- Treating others fairly, equally and respecting their individual dignity.

- Recognizing individual worth.
- Supporting creativity, innovation, and constructive changes in the organization.
- Demonstrating accountability for our performance, actions, and behavior.
- Doing the professional, technical, organizational, and ethically “right” thing as opposed to the easy, popular, or politically expedient thing.
- Demonstrating a high level of social responsibility.

ARTICLE I

MEMBERSHIP

Section 1.1.

Except as otherwise provided in these bylaws, any person, without regard to race, creed, color, national origin, sex, or political belief, shall be eligible for membership.

Section 1.1.1. Active Member.

Any classified school employee who is regularly employed by or for the Chehalis School District, and who is a member of Public School Employees of Washington / SEIU Local 1948, is eligible for membership in this chapter. A classified employee is one whose position does not require a teaching certificate.

Section 1.1.2. Member in Good Standing.

To be eligible to vote and to hold office, a member must be in good standing. To be in good standing, the member shall be employed and current in payment of dues as are required by these bylaws. Any member who is on authorized leave of absence pursuant to the collective bargaining agreement shall retain the right to vote and hold office. Any member who is terminated from employment shall not be eligible to vote or hold office.

ARTICLE II

DUES

Section 2.1. State Dues.

State dues shall be paid monthly to the state office of PSE as outlined in the state bylaws.

Section 2.1.1. Chapter Rebates.

Dues rebates from the state organization shall be received by the chapter in accordance with the provisions of the state bylaws.

1 **Section 2.2. Local Dues.**

2 Local monthly membership dues of this organization shall be one dollar (\$1.00) through payroll
3 deduction which will be submitted to the chapter monthly.
4

5 **Section 2.2.1.**

6 When a member is unemployed for more than twenty (20) days in a calendar month and does not
7 receive unemployment compensation or sick pay or other remuneration, they may be entitled to
8 credit for local dues for the period of unemployment, not to exceed six (6) months in any calendar
9 year.
10

11 **Section 2.3. Refunds.**

12 Membership dues are not refundable except where an error resulting in an overpayment exists.

16 **A R T I C L E I I I**

18 **G O V E R N A N C E A N D O P E R A T I O N S**

20 **Section 3.1.**

21 PSE shall be governed by a representative form of government.
22

23 **Section 3.2.**

24 Members shall suffer no impairment of freedom of speech concerning the operations of this organization.
25 Active discussions of organization affairs shall be encouraged and protected within this organization.
26

27 **Section 3.3.**

28 Members shall have the right to a full and clear accounting of all organizational funds. At all levels such
29 accounting shall include, but not be limited to, periodic reports to the membership by appropriate fiscal
30 officers or by independent auditors not otherwise connected with the organization, and a financial audit at
31 least once a year which is made available to all members.
32

33 **Section 3.4.**

34 Members shall have the right to full participation, through discussion and vote, in the decision making
35 processes of the organization and to pertinent information needed for the exercises of this right.
36

37 **Section 3.5. GOVERNING BODY.**

38
39 **Section 3.5.1. Board of Trustees.**

40 Except when general meetings of the chapter are in session, the business and property of this
41 chapter shall be managed by a Board of Trustees. The authority to govern and act on behalf of the
42 membership is vested in the elected Board of Trustees who shall decide all matters affecting the
43 purposes, aims and means of accomplishing the purposes of this chapter, not specifically provided
44 for in these bylaws or by action of the members at a regular or special meeting.

1 **Section 3.5.2. PSE Field Staff.**

2 PSE field staff shall work closely with the chapter in an advisory position. All decisions
3 governing the business of the local chapter shall be the sole responsibility of the elected officials
4 and membership of the chapter.
5

6 **Section 3.6. OPERATING PRINCIPLES.**

7 In order to provide the chapter with the highest quality direction and management possible, the following
8 operating principles shall guide the Board of Trustees.
9

10 **Section 3.6.1. Board/Membership Relationships.**

11 A positive, constructive, cooperative relationship between the Board of Trustees and the
12 membership is essential to achieving the mission and vision of the organization. Therefore, the
13 board and membership will conduct themselves in a way that promotes mutual trust, demonstrates
14 respect for individual dignity, and displays professionalism. The board shall utilize positive
15 conflict resolution methods and maintain open, honest lines of communication that respect an
16 appropriate chain of command within the chapter.
17

18 **Section 3.6.2. Media.**

19 The president, or his/her designee, is the primary spokesperson for the chapter. Media inquiries to
20 individual board members about matters of chapter concern should be referred to the chapter
21 president. Inquiries about a position of PSE on any matter of statewide concern or specific
22 legislation should be referred to the executive director at state headquarters.

26 **ARTICLE IV**

27 **MEETINGS**

28
29 **Section 4.1.**

30 General membership meetings of this chapter shall be held at least four (4) times annually at a time and
31 place to be fixed by the membership or the Board of Trustees.
32

34 **Section 4.2.**

35 Special meetings may be called by the president, the Board of Trustees, or by petition filed with the
36 president and signed by twenty percent (20%) of the members in good standing of this chapter.
37

38 **Section 4.3.**

39 The president shall provide at least five (5) days notification to all members of any meeting called.
40 However, said five (5) days notice may be waived by the Board of Trustees provided that every
41 reasonable effort is employed to notify the membership of the meeting.
42

43 **Section 4.4.**

44 At any meeting of the membership of this chapter, each member in good standing present shall be entitled
45 to one vote. A member must be present to vote; no proxy vote will be allowed. A majority of the
46 members in attendance shall constitute a quorum.
47

1 **Section 4.5. Board of Trustees Meetings.**

2 Meetings of the Board of Trustees shall be called at the discretion of the president. Meetings may also be
3 called upon motion of a majority of the members of the Board of Trustees to the president. A majority of
4 the members of the Board of Trustees shall constitute a quorum.

5
6 **Section 4.6.**

7 The latest edition of Robert's Rules of Order shall be a reference guide on conducting business at
8 meetings; provided that they shall be superseded by the bylaws and special rules of this chapter or of
9 Public School Employees of Washington / SEIU Local 1948.

13 **ARTICLE V**

14
15 **BOARD OF TRUSTEES**

16
17 **Section 5.1.**

18 The Board of Trustees shall be composed of the president, vice president, secretary, membership officer,
19 treasurer, and a unit representative (herein known as a trustee) elected by the unit from each classification
20 of employees of the school district if represented by the local Public School Employees organization.

21
22 **Section 5.2.**

23 The term of office shall be for a period of two (2) years, or until their successors are elected.

24
25 **Section 5.3.**

26 The Board of Trustees shall hold regular meetings and such special meetings as the president or the board
27 shall deem necessary for the competent management of affairs of the chapter.

28
29 **Section 5.4.**

30 Each member of the Board of Trustees shall possess one (1) vote in matters coming before the board. All
31 voting at meetings of the Board of Trustees shall be by each member present in person, and voting by
32 proxy shall not be allowed. A majority of the members of the Board of Trustees shall constitute a
33 quorum.

34
35 **Section 5.5. Duties.**

36
37 **Section 5.5.1. President.**

38 The president shall preside at all meetings of the chapter and of the Board of Trustees. The
39 president shall be made aware of, and supervise all activities of the chapter; execute all
40 instruments in its behalf; and work with PSE field staff, with the advice and consent of the Board
41 of Trustees, to achieve the mission, vision, goals, and objectives of the chapter. The president
42 shall appoint all special committees not otherwise provided for in the bylaws of the chapter,
43 subject to the approval of the Board of Trustees, and serve as an ex-officio member of all
44 committees. The president shall report periodically to the membership regarding the progress and
45 standing of the chapter in regard to the president's official acts; and perform all other duties of the
46 office.

1 **Section 5.5.2. Vice President.**

2 The vice president shall provide such assistance to the president as requested; serve as chairperson
3 of the grievance committee; shall, in the absence of the president, perform duties of that office;
4 and in the case of permanent disability or resignation of the president, shall succeed to that office
5 for the unexpired portion of the current term of office.
6

7 **Section 5.5.3. Secretary.**

8 The secretary shall ensure that the minutes of general membership meetings and Board of Trustee
9 meetings are duly recorded. It shall be the duty of the secretary to keep all records of the chapter,
10 the Board of Trustees, and to perform such other official functions as the president and Board of
11 Trustees may direct.
12

13 **Section 5.5.4. Treasurer.**

14 The treasurer shall receive and be accountable for all funds and monies belonging to the chapter;
15 pay all obligations incurred by the chapter as authorized by the Board of Trustees; keep an
16 accurate record of receipts and disbursements; and maintain bank accounts and depositories
17 designated by the Board of Trustees. Such money shall be withdrawn only by checks signed by
18 the president and/or vice president and the treasurer. The treasurer shall render periodical
19 financial reports as required by the Board of Trustees, the membership, or Public School
20 Employees of Washington / SEIU Local 1948 to ensure that the chapter is in compliance with all
21 laws and regulations required by the Internal Revenue Service and the Department of Labor. The
22 fiscal year for all financial reports shall be from September 1 to August 31 of the following year,
23 inclusive. The treasurer shall act as custodian of all properties of the chapter. It shall be the duty
24 of the treasurer to maintain a current and accurate list of members of the chapter in coordination
25 with the membership information section at PSE state headquarters; ensure that all members are
26 paying dues; render periodical membership reports as required by Public School Employees of
27 Washington.
28

29 **Section 5.5.5. Trustee.**

30 A trustee shall represent the classification of employees which elected them and express to the
31 Board of Trustees the needs, desires, and concerns of the members in their classification. They
32 will be responsible, along with the grievance committee, in advising an employee about their
33 contractual rights.
34

35 **Section 5.5.6. Membership Officer.**

36 It shall be the duty of the membership officer to maintain a current and accurate list of members of
37 the chapter in coordination with the membership information section at PSE state headquarters;
38 ensure that all members are paying dues; render periodic membership reports as required by Public
39 School Employees of Washington / SEIU Local 1948; and perform such other official functions as
40 the president and Board of Trustees may direct.

ARTICLE VI

ELECTIONS, FILLING OF VACANCIES, AND RECALL PROCEDURES

Section 6.1.

Members shall have the right to fair and democratic elections at all levels of the chapter. This includes ten (10) working days notice of nominations and elections, and equal opportunities for competing candidates to state their qualifications and reasons for seeking office to the chapter membership. Elections shall be conducted by secret written ballot and certified by the chapter secretary.

Section 6.2.

Members shall have an equal right to run and hold office, except those persons set forth in RCW 41.56.030 Par. 11, and those employees classified either by state statute or appropriate state regulatory agencies as being a “supervisory employee.”

Section 6.3.

All officers and trustees shall be elected for a term of two (2) years, or until their successors are elected and elections shall be held every spring. In odd-numbered years, the president, secretary, and transportation trustee shall be elected. In even-numbered years, the vice president, treasurer, and monitor trustee shall be elected. Terms of office shall be from September 1 through August 31.

Section 6.4.

Nominations may be made by the nominating committee, but whether or not such nominating committee is used, nominations shall be permitted from the floor at the meeting held for the election.

Section 6.5.

Members of the Board of Trustees shall be elected by secret ballot vote, and the balloting shall be so conducted as to afford all members a reasonable opportunity to vote. At least ten (10) working days advance notice shall be given the membership prior to the holding of the election.

Section 6.5.1.

All members of the chapter shall be eligible to vote for the positions of president, vice president, secretary, membership officer, and treasurer. In the election of a trustee, only members in the classification of employees that the trustee will represent shall be allowed to vote.

Section 6.6.

Every member of the Board of Trustees shall, upon assuming office, subscribe to the obligations contained in these bylaws.

Section 6.7.

Any member of the Board of Trustees may be removed from office by a two-thirds (2/3) vote of the membership at any regular or special meeting of the chapter. Written notice of the proposed removal must be given to the Board of Trustee member at least five (5) working days prior to the date of the meeting at which the removal is to be voted upon. Such notice must state the cause for the proposed removal.

1 **Section 6.8.**

2 Unexcused absences from three (3) consecutive meetings of the Board of Trustees shall be due cause for
3 removal of the member by the Board of Trustees. Removal of a board member because of excessive
4 absenteeism shall not require the 2/3 vote of the membership.
5

6 **Section 6.9.**

7 A vacancy in any position, except that of president, shall be filled by the Board of Trustees in accordance
8 with the procedures set forth below:
9

10 **Section 6.9.1.**

11 In the event the president cannot serve the remainder of his/her current term, the vice president
12 shall serve as president for the completion of the term.
13

14 **Section 6.9.2.**

15 In the event of a vacancy in the office of vice president, secretary, membership officer, or
16 treasurer, all members shall be notified of the vacancy and nominations solicited for the position.
17 Nominations shall be accepted for a period of twenty (20) calendar days following the notification
18 to members. The president, at his/her discretion, may either call a special meeting of the Board of
19 Trustees, or act upon the vacancy at the next regularly scheduled board meeting. Each candidate
20 for the position may submit a letter, or have three (3) minutes to address the board prior to the vote
21 to describe their qualifications and reasons they are seeking the position.
22

23 **Section 6.9.3.**

24 Any other vacancy shall be filled only for the remainder of the term in which the vacancy occurs;
25 provided, however, that when vacancies occur in the office of trustee, the president shall direct
26 that a classification meeting be held and that the classification elect a successor for the remainder
27 of the vacant term. Election of the successor must be by majority vote. In the event that more
28 than two candidates run for the office, the candidate with the lowest vote total will be dropped
29 from the ballot after each round of voting until one candidate receives a majority of the votes cast.

33 **ARTICLE VII**

34 **MISCELLANEOUS PROVISIONS**

35 **Section 7.1.**

36 Local chapters shall adopt bylaws that do not conflict with PSE state bylaws. State bylaws shall always
37 supersede local bylaws where conflict exists.

41 **Section 7.2.**

42 This chapter shall send to the PSE state office a list of names and addresses of its Board of Trustees and
43 members, together with other information required by PSE and shall notify PSE of all changes in board
44 members, members, and addresses.

1 **Section 7.3.**

2 This chapter shall not enter into any collective bargaining agreement, amendment thereto, dispute
3 settlement agreement, grievance settlement agreement, or any other agreement or waiver which affects or
4 pertains to wages, hours or working conditions of the employees in the bargaining unit, nor any
5 agreement which would affect the rights of employees represented by PSE, nor any agreement affecting
6 the scope of any collective bargaining unit, with the district, employer, or other entity or agent, unless
7 such agreement is first reviewed and approved by the executive director of Public School Employees of
8 Washington / SEIU Local 1948 or his/her designee, provided decisions of the executive director may be
9 appealed to the Board of Directors.
10

11 **Section 7.3.1.**

12 Original signed copies of all documents pertaining to issues outlined in Section 7.3 shall be
13 submitted to the regional service center, who will then forward the original to state headquarters
14 after appropriate copies have been made.

17 **ARTICLE VIII**

18 **COMMITTEES AND DELEGATES**
19
20
21

22 **Section 8.1. Grievance Committee.**

23 A grievance committee shall be composed of the vice president and at least three (3) additional chapter
24 members; and shall be responsible for advising members of their rights as outlined in the state bylaws,
25 Article XIV, State Grievance Panel.
26

27 **Section 8.2. Negotiating Committee.**

28 The Board of Trustees shall serve as the negotiating committee and shall work with the PSE field
29 representative in developing proposals and negotiating agreements.
30

31 **Section 8.3. Annual Convention Delegates.**

32 Delegates shall be elected by secret ballot. Approved expenses incurred by elected delegates attending
33 the annual convention shall be paid by the chapter or in accordance with appropriate provisions of PSE
34 state bylaws.
35

36 **Section 8.4. Audit Committee.**

37 An audit committee shall be selected by the Board of Trustees to audit the financial records of the chapter.
38

39 **Section 8.5. Other or Special Committees.**

40 The Board of Trustees shall designate such special committees as they determine necessary in the
41 carrying out of the objectives and purposes of this chapter.

ARTICLE IX

AMENDMENTS
