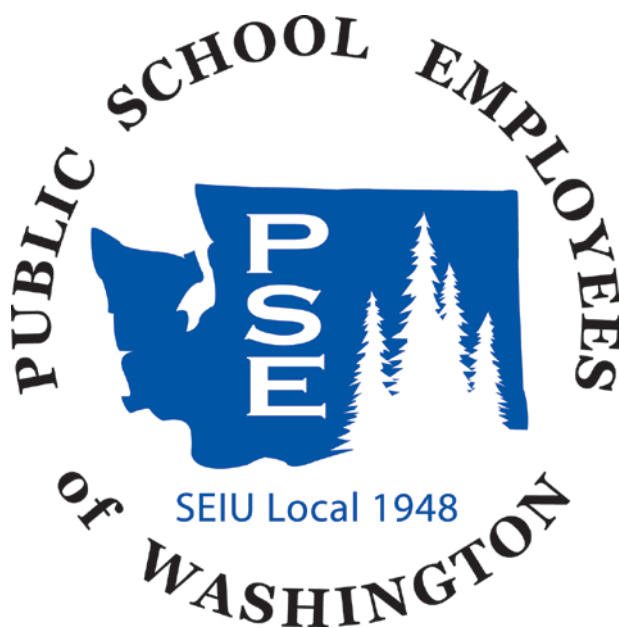

P R E A M B L E

A. NAME

The name of this chapter shall be Public School Employees of Columbia/Hunters and shall be an affiliate of Public School Employees of Washington/SEIU Local 1948, a not-for-profit 501(c) 5 labor organization operating under the laws of the State of Washington.

B. MISSION - OUR PURPOSE FOR EXISTING

It is the mission of Public School Employees of Columbia/Hunters to work closely with Public School Employees of Washington/SEIU Local 1948 to support the membership through collective bargaining and the protection of those rights, promote educational enrichment opportunities, encourage membership growth, and provide quality leadership while working closely with the State Legislature in an effort to enact laws which will represent the best interest of all classified school employees in the state of Washington.

ARTICLE I
MEMBERSHIP

Section 1.1.

Except as otherwise provided in these Bylaws, any person, without regard to race, creed, color, national origin, sex, or political belief, shall be eligible for membership.

Section 1.1.1. Active Member.

Any classified school employee who is regularly employed by or for the Columbia/Hunters School District, and who is a member of Public School Employees of Washington / SEIU Local 1948, is eligible for membership in this Chapter. A classified employee is one whose position does not require a teaching certificate.

Section 1.1.2. Member In Good Standing.

To be eligible to vote and to hold office, a member must be in good standing. To be in good standing, the member shall be employed and current in payment of dues as are required by these Bylaws. Any member, who is on authorized leave of absence pursuant to the Collective Bargaining Agreement, shall retain the right to vote and hold office. Any member who is terminated from employment shall not be eligible to vote or hold office.

ARTICLE II

Section 2.1. State Dues.

State dues shall be paid monthly to the State Office of PSE as outlined in the State Bylaws.

Section 2.1.1. Chapter Rebates.

Dues rebates from the State organization shall be received by the Chapter in accordance with the provisions of the State Bylaws.

Section 2.2. Local Dues.

Local membership dues shall be one dollar (\$1.00) per month. Local dues shall be paid monthly to the Chapter Treasurer by each member. Any member, who is on an authorized leave of absence pursuant to the Collective Bargaining Agreement, may have local dues collection suspended upon approval by the Chapter Board of Trustees.

Section 2.3. Refunds.

Membership dues are not refundable except where an error resulting in an overpayment exists.

ARTICLE III
GOVERNANCE AND OPERATIONS

Section 3.1.

PSE shall be governed by a representative form of government.

Section 3.2.

Members shall suffer no impairment of freedom of speech concerning the operations of this organization. Active discussions of organization affairs shall be encouraged and protected within this organization.

Section 3.3.

Members shall have the right to a full and clear accounting of all organizational funds. At all levels such accounting shall include, but not be limited to, periodic reports to the membership by appropriate fiscal officers or by independent auditors not otherwise connected with the organization, and a financial audit at least once a year which is made available to all members.

Section 3.4.

Members shall have the right to full participation, through discussion and vote, in the decision making processes of the organization and to pertinent information needed for the exercises of this right.

Section 3.5.

The chapter members shall ratify the final negotiated collective bargaining agreement and any related documentation between the Chapter and Columbia/Hunters School District at a regular or special meeting before it is signed.

Section 3.6. GOVERNING BODY.

Section 3.6.1. Board of Trustees.

Except when general meetings of the Chapter are in session, the business and property of this Chapter shall be managed by a Board of Trustees. The authority to govern and act on behalf of the membership is vested in the elected Board of Trustees who shall decide all matters affecting the purposes, aims and means of accomplishing the purposes of this Chapter, not specifically provided for in these Bylaws or by action of the members at a regular or special meeting.

Section 3.6.2. PSE Field Staff.

PSE Field Staff shall work closely with the Chapter in an advisory position. All decisions governing the business of the local Chapter shall be the sole responsibility of the elected officials and membership of the Chapter.

Section 3.7. OPERATING PRINCIPLES.

In order to provide the Chapter with the highest quality direction and management possible, the following operating principles shall guide the Board of Trustees.

1 **Section 3.7.1. Board/Membership Relationships.**

2 A positive, constructive, cooperative relationship between the Board of Trustees and the
 3 membership is essential to achieving the mission and vision of the organization. Therefore, the
 4 Board and membership will conduct themselves in a way that promotes mutual trust,
 5 demonstrates respect for individual dignity, and displays professionalism. The Board shall
 6 utilize positive conflict resolution methods and maintain open, honest lines of communication
 7 that respect an appropriate chain of command within the Chapter.
 8

9 **Section 3.7.2. Media.**

10 The President, or his/her designee, is the primary spokesperson for the Chapter. Media
 11 inquiries to individual Board members about matters of Chapter concern should be referred to
 12 the Chapter President. Inquiries about a position of PSE on any matter of statewide concern or
 13 specific legislation should be referred to the Executive Director at State headquarters.

17 **A R T I C L E I V**

19 **M E E T I N G S**

21 **Section 4.1.**

22 General membership meetings of this Chapter shall be held at least four (4) times annually at a time
 23 and place to be fixed by the membership or the Board of Trustees.
 24

25 **Section 4.2.**

26 Special meetings may be called by the President, the Board of Trustees, or by petition filed with the
 27 President and signed by twenty percent (20%) of the members in good standing of this Chapter.
 28

29 **Section 4.3.**

30 The President shall provide at least five (5) days notification to all members of any meeting called.
 31 However, said five (5) days notice may be waived by the Board of Trustees provided that every
 32 reasonable effort is employed to notify the membership of the meeting.
 33

34 **Section 4.4.**

35 At any meeting of the membership of this Chapter, each member in good standing present shall be
 36 entitled to one vote. A member must be present to vote -- no proxy vote will be allowed. The majority
 37 of those in attendance will constitute a quorum.
 38

39 **Section 4.5 Board of Trustee Meetings.**

40 Meetings of the Board of Trustees shall be called at the discretion of the President. Meetings may also
 41 be called upon motion of a majority of the members of the Board of Trustees to the President. A
 42 majority of the members of the Board of Trustees shall constitute a quorum.

1 **Section 4.6.**

2 The latest edition of Robert's Rules of Order Newly Revised shall be a reference guide on conducting
3 business at meetings; provided, that they shall be superseded by the Bylaws and special rules of this
4 Chapter or of the Public School Employees of Washington/SEIU Local 1948.

8 **ARTICLE V**

9
10 **BOARD OF TRUSTEES**

11
12 **Section 5.1.**

13 The Board of Trustees shall be composed of the President, Vice President, Secretary, Treasurer, and a
14 unit representative (herein known as a Trustee) elected by the unit from each classification of
15 employees of the school district if represented by the local Public School Employees organization.
16

17 **Section 5.2.**

18 The term of office shall be for a period of two (2) years, or until their successors are elected.
19

20 **Section 5.3.**

21 The Board of Trustees shall hold regular meetings, and such special meetings as the President or the
22 Board shall deem necessary for the competent management of affairs of the Chapter.
23

24 **Section 5.4.**

25 Each member of the Board of Trustees shall possess one (1) vote in matters coming before the Board.
26 All voting at meetings of the Board of Trustees shall be by each member present in person, and voting
27 by proxy shall not be allowed. A majority of the members of the Board of Trustees shall constitute a
28 quorum.
29

30 **Section 5.5. Duties.**

31
32 **Section 5.5.1. President.**

33 The President shall preside at all meetings of the Chapter and of the Board of Trustees. The
34 President shall be made aware of, and supervise all activities of the Chapter; execute all
35 instruments in its behalf; and work with PSE Field Staff, with the advice and consent of the
36 Board of Trustees, to achieve the mission, vision, goals, and objectives of the Chapter. The
37 President shall appoint all special committees not otherwise provided for in the bylaws of the
38 Chapter, subject to the approval of the Board of Trustees, and serve as an ex-officio member of
39 all committees. The President shall report periodically to the membership regarding the
40 progress and standing of the Chapter in regards to the President's official acts and perform all
41 other duties of the office.

1 **Section 5.5.2. Vice President.**

2 The Vice President shall provide such assistance to the President as requested; serve as
3 Chairperson of the Grievance Committee; shall, in the absence of the President, perform duties
4 of that office; and in the case of permanent disability or resignation of the President, shall
5 succeed to that office for the unexpired portion of the current term of office.
6

7 **Section 5.5.3. Secretary.**

8 The Secretary shall ensure that the minutes of general membership meetings and Board of
9 Trustee meetings are duly recorded. It shall be the duty of the Secretary to keep all records of
10 the Chapter, the Board of Trustees, and to perform such other official functions as the President
11 and Board of Trustees may direct.
12

13 **Section 5.5.4. Treasurer.**

14 The Treasurer shall receive and be accountable for all funds and monies belonging to the
15 Chapter; pay all obligations incurred by the Chapter as authorized by the Board of Trustees;
16 keep an accurate record of receipts and disbursements; and maintain bank accounts and
17 depositories designated by the Board of Trustees. Such money shall be withdrawn only by
18 checks signed by the President and/or Vice President and the Treasurer. The Treasurer shall
19 render periodic financial reports as required by the Board of Trustees, the membership, or
20 Public School Employees of Washington/SEIU Local 1948 to ensure that the Chapter is in
21 compliance with all laws and regulations required by the Internal Revenue Service and the
22 Department of Labor. The fiscal year for all financial reports shall be from September 1 to
23 August 31 of the following year, inclusive. The Treasurer shall act as custodian of all
24 properties of the Chapter.
25

26 It shall be the duty of the Treasurer to maintain a current and accurate list of members of the
27 Chapter in coordination with the membership information section at PSE State headquarters;
28 ensure that all members are paying dues; render periodic membership reports as required by
29 Public School Employees of Washington/SEIU Local 1948; and perform such other official
30 functions as the President and Board of Trustees may direct.
31

32 **Section 5.5.5. Trustee.**

33 A Trustee shall represent the classification of employees which elected them and express to the
34 Board of Trustees the needs, desires, and concerns of the members in their classification. They
35 will be responsible, along with the Grievance Committee, in advising an employee about their
36 contractual rights.

40 **ARTICLE VI**

41 **ELECTIONS, FILLING OF VACANCIES, AND RECALL PROCEDURES**

42 **Section 6.1.**

43 Members shall have the right to fair and democratic elections at all levels of the Chapter. This includes
44 ten (10) workdays notice of nominations and elections, and equal opportunities for competing
45

1 candidates to state their qualifications and reasons for seeking office to the Chapter membership.
2 Elections shall be conducted by secret written ballot and certified by the Chapter Secretary.

3
4 **Section 6.2.**

5 Members shall have an equal right to run and hold office, except those persons set forth in
6 RCW 41.56.030 Par. 2, a, b and c, and those employees classified either by State statute or appropriate
7 State regulatory agencies as being a "supervisory employee."

8
9 **Section 6.3.**

10 Elections shall be held during the month of May. Terms of office shall be from September 1 through
11 August 31.

12
13 **Section 6.4.**

14 Nominations may be made by the nominating committee, but whether or not such nominating
15 committee is used, nominations shall be permitted from the floor at the meeting held for the election.

16
17 **Section 6.5.**

18 To be eligible, a member must be in good standing for one (1) year immediately preceding the election.

19
20 **Section 6.6.**

21 Members of the Board of Trustees shall be elected by secret ballot vote, and the balloting shall be so
22 conducted as to afford all members a reasonable opportunity to vote. At least ten (10) workdays
23 advance notice shall be given the membership prior to the holding of the election.

24
25 **Section 6.6.1.**

26 All members of the Chapter shall be eligible to vote for the positions of President, Vice
27 President, Secretary, and Treasurer. In the election of a Trustee, only members in the
28 classification of employees that the Trustee will represent shall be allowed to vote.

29
30 **Section 6.7.**

31 Every member of the Board of Trustees shall, upon assuming office, subscribe to the obligations
32 contained in these Bylaws.

33
34 **Section 6.8.**

35 Any member of the Board of Trustees may be removed from office by a two-thirds (2/3) vote of the
36 membership at any regular or special meeting of the Chapter. Written notice of the proposed removal
37 must be given to the Board of Trustee member at least five (5) workdays prior to the date of the
38 meeting at which the removal is to be voted upon. Such notice must state the cause for the proposed
39 removal.

40
41 **Section 6.9.**

42 Unexcused absences from three (3) consecutive meetings of the Board of Trustees shall be due cause
43 for removal of the member by the Board of Trustees. Removal of a Board member because of
44 excessive absenteeism shall not require the 2/3 vote of the membership.

1 **Section 6.10.**

2 A vacancy in any position, except that of President, shall be filled by the Board of Trustees in
3 accordance with the procedures set forth below:
4

5 **Section 6.10.1.**

6 In the event the President cannot serve the remainder of his/her current term, the Vice President
7 shall serve as President for the completion of the term.
8

9 **Section 6.10.2.**

10 In the event of a vacancy in the office of Vice President, Secretary, or Treasurer, all members
11 shall be notified of the vacancy and nominations solicited for the position. Nominations shall
12 be accepted for a period of twenty (20) calendar days following the notification to members.
13 The President, at his/her discretion, may either call a special meeting of the Board of Trustees,
14 or act upon the vacancy at the next regularly scheduled Board meeting. Each candidate for the
15 position may submit a letter, or have three (3) minutes to address the Board prior to the vote to
16 describe their qualifications and reasons they are seeking the position.
17

18 **Section 6.10.3.**

19 Any other vacancy shall be filled only for the remainder of the term in which the vacancy
20 occurs; provided, however, that when vacancies occur in the office of Trustee, the President
21 shall direct that a classification meeting be held and that the classification elect a successor for
22 the remainder of the vacant term. Election of the successor must be by majority vote. In the
23 event that more than two candidates run for the office, the candidate with the lowest vote total
24 will be dropped from the ballot after each round of voting until one candidate receives a
25 majority of the votes cast.

29 **ARTICLE VII**

30 **MISCELLANEOUS PROVISIONS**

31 **Section 7.1.**

32 Local chapters shall adopt bylaws that do not conflict with PSE State Bylaws. State Bylaws shall
33 always supersede local bylaws where conflict exists.
34

35 **Section 7.2.**

36 This Chapter shall send to the PSE State office a list of names and addresses of its Board of Trustees
37 and members, together with other information required by PSE and shall notify PSE of all changes in
38 Board members, members, and addresses.

41 **Section 7.3.**

42 This Chapter shall not enter into any collective bargaining agreement, amendment thereto, dispute
43 settlement agreement, grievance settlement agreement, or any other agreement or waiver which affects or
44 pertains to wages, hours or working conditions of the employees in the bargaining unit, nor any agreement
45 which would affect the rights of employees represented by PSE, nor any agreement affecting the scope of
46



1 any collective bargaining unit, with the District, Employer, or other entity or agent, unless such agreement
2 is first approved by the Executive Director of Public School Employees of Washington/SEIU Local 1948
3 or his/her designee, provided decisions of the Executive Director may be appealed to the Board of
4 Directors.

5
6 **Section 7.3.1.**

7 Original signed copies of all documents pertaining to issues outlined in Section 7.3 shall be
8 submitted to the Regional Service Center, who will then forward the original to State
9 headquarters after appropriate copies have been made.

13 **ARTICLE VIII**

14
15 **COMMITTEES AND DELEGATES**

16
17 **Section 8.1. Grievance Committee.**

18 A Grievance Committee shall be composed of the Vice President and at least one (1) unit representative
19 from each classification of employees in the Chapter; and shall be responsible for advising members of
20 their rights as outlined in the State Bylaws, Article XIV, State Grievance Panel.

21
22 **Section 8.2. Negotiating Committee.**

23 A Negotiating Committee shall consist of a representative elected from each classification of
24 employees represented by this bargaining unit and shall work with the PSE Field Representative in
25 developing proposals and negotiating agreements.

26
27 **Section 8.3. Annual Convention Delegates.**

28 Delegates shall be elected by secret ballot. Approved expenses incurred by elected delegates attending
29 the Annual Convention shall be paid by the Chapter or in accordance with appropriate provisions of PSE
30 State Bylaws.

31
32 **Section 8.4. Audit Committee**

33 An Audit Committee shall be selected by the Board of Trustees to audit the financial records of the
34 Chapter.

35
36 **Section 8.5. Other or Special Committees.**

37 The Board of Trustees shall designate such special committees as they determine necessary in the
38 carrying out of the objectives and purposes of this Chapter.
