# 17 Section 1. Eligibility.

Except as otherwise provided in these Bylaws, any person without regard to race, color, national origin, gender identification, disability or political belief, who meets the requirements hereinafter listed shall be eligible for membership.

- A. All persons regularly employed as a classified school employee (as defined by the Public School Employees of Washington) by or in Conway School District, and who are members of the Public School Employees of Washington, are eligible for membership in the organization.
- 25 B. Definition of a "Free Rider" Any member that opts out of payment of dues or fails to become a 26 member of the Conway Chapter of Public School Employees Washington/SEIU Local 1948 shall 27 be entitled only to those rights and privileges set forth in the Conway PSE Policy and Bylaws. 28 Free Rider members shall not be entitled to hold any office, attend local or state meetings, vote 29 for local or state leaders, or vote for ratification of Conway collective bargaining agreements. In 30 addition, Free Rider members may not attend any Conway PSE sponsored functions. No Free 31 Rider members may serve on any committee. A former Free Rider member may serve on a 32 committee under the following conditions: sign a PSE/SEIU Local 1948 membership card and a 33 regular dues paying member for at least twelve (12) consecutive months. 34

# 36 Section 2. Local Dues.

- A. Application for membership shall be made on a standard application form provided by the Board
   of Trustees. Unless such form includes a valid authorization for payroll deduction of dues, the
   application shall be accompanied by the current months dues.
- B. The District is authorized to deduct five dollars (\$5.00) monthly from all member's gross
  earnings; such deduction shall be deposited in the bank account of Conway Public School
  Employees. The purpose of such deduction is to support the cost of local chapter administration
  and scholarships.
- 46 C. Membership dues are not refundable except where an error resulting in an overpayment exists.

#### Section 3. 13

The President shall provide at least five (5) days' notification to all members of any meeting called. 14

However, said five (5) days' notice may be waived by the Board of Trustees provided that every 15

reasonable effort is employed to notify the membership of the meeting. 16

#### Section 4. 18

At any meeting of the membership of this organization, each member present shall be entitled to one (1) 19

vote. A member must be present to vote – no proxy vote will be allowed however, online voting is 20

permitted when the meeting is conducted via Zoom. A minimum of five (5) members must be present to 21 constitute a quorum before any organization business may be transacted. 22

# ARTICLE VII

#### 27 28 <u>MANAGEMENT</u>

#### Section 1. 30

The business and property of this organization shall be managed by a Board of Trustees, except when 31 the meetings of the organization are in session. All matters affecting the purposes, aims and means of 32 accomplishing the purposes of this organization, not specifically provided for in these Bylaws or by 33 action of the members at a regular or special meeting shall be decided by the Board of Trustees. 34

#### 35 Section 2. 36

The Board of Trustees shall be composed of the President, Vice President, Secretary, Treasurer and a 37 unit representative elected by the unit from each of the following classifications of employees of the 38 school district if represented by the local Public School Employees organization. 39

#### Section 3. 1

The term of office of the Trustees of this organization shall be for a period of two (2) years from the date 2 of election. 3

#### Section 4. 5

The Board of Trustees shall hold meetings as the President or the Board shall deem necessary for the 6 competent management of affairs of the organization. 7

#### Section 5. 9

Each member of the Board of Trustees shall possess one (1) vote in matters coming before the Board. 10

All voting at meetings of the Board of Trustees shall be by each member present in person, and voting 11

by proxy shall not be allowed, with the exception of meeting that is conducted online. A majority of the 12

members of the Board of Trustees shall constitute a quorum. 13 14

#### Section 6. 15

Any trustee may be removed from office by a two-thirds (2/3) majority vote of the membership at any 16

- regular or special meeting of the membership of the organization. Notice of the proposed removal of the 17
- Trustee must be given to the Trustee five (5) days prior to the date of the meeting at which the removal 18

is to be voted upon. Such notice to the Trustee must state the cause for the proposed removal. 19

#### 20 Section 7. 21

Unexcused absences from three (3) consecutive meetings of the Board of Trustees shall be due cause for 22 removal of the trustee by the Board of Trustees. Removal of a Board member because of excessive 23 absenteeism shall not require the 2/3 vote of the membership. 24

#### 25 Section 8. 26

Any vacancies occurring on the Board of Trustees by reason of death, resignation or removal shall be 27 filled by the remaining trustee. In the event that such Trustee is an Officer, such selection shall be from 28 the membership at large. All other Trustees' vacancies shall be filled from the classification of which 29 they are representatives. Such appointee shall serve during the unexpired term of the Trustee whose 30 position has become vacant. 31

# 19 Section 1. President.

The President shall preside at all meetings of the organization and of the Board of Trustees. The

21 President shall supervise all activities of the organization; execute all instruments in its behalf; counter-

sign all checks drawn again the fund of the organization; appoint all special committees of the

organization subject to the approval of the Board of Trustees; report periodically to the membership

regarding the progress and standing of the organization in regard to the President's official acts; perform

all other duties as prescribed in the Bylaws and perform such other duties usually inherent in such office.

# 27 Section 2. Vice President.

The Vice President shall act for the President in the President's absence and perform such other acts as the President or Board of Trustees may direct. The Vice President may be authorized, by the Board of

Trustees, to act as a co-signer of checks drawn on the funds of the organization in place of or in addition

to either the President or Secretary.

# 33 Section 3. Secretary.

It shall be the duty of the Secretary to keep all records of the organization, minutes of general

membership meetings and minutes of Board of Trustees meetings. The Secretary shall perform such
