29 30	The name of this organization shall be the Public School Employees/SEIU Local 1948 of Fife School District Number 417.

34	ARTICLE II
35	
36	This local organization shall be affiliated with and be a chapter of the Public School Employees/SEIU
37	Local 1948 of Washington. This organization was chartered by Public School Employees of Washington
38	on December 1, 1967.

44	This organization shall continue until a majority of all of the members vote to dissolve the organization.

To promote the welfare of the membership and the classified employees of the Fife School District #417, and to provide a voice in the determination of the terms and conditions of employment. We are committed to the process of collective bargaining as a desirable, democratic and effective method to achieve this.

To promote and provide systematic and effective employee management through collective bargaining; to confer and negotiate in good faith, with respect to grievance procedures and collective negotiations on personnel matters, including wages, hours and working conditions vacations, holidays and other conditions of employment for the classified employees of Fife School District #417.	,
21 22 23 24	E. Both as members and as citizens, we shall also employ available legislative and political active to establish adequate financial provisions for the improvement of public school education and equitable consideration for the classified school employees from the State Legislators.

35 36 37 38 39	<u>Section 1. Eligibility.</u> Except as otherwise provided in these Bylaws, any person without regard to race, creed, color, national origin, sex or political belief, who meets the requirements hereinafter listed shall be eligible for membership.	
40 41 42 43 44	A. All persons regularly employed as a classified school employee (as defined by the Public School Employees of Washington) by or in Fife School District #417, and who are members in good standing of the Public School Employees of Washington, are eligible for membership in the organization.	
45 46 47 48	B. Free riders: Employees covered by the collective bargaining agreement but who do not pay dues. Free riders are not eligible to attend meetings, hold office, or vote. Free riders and their dependents are not eligible for scholarships and local emergency relief funds.	7



Section 2.	Local Dues.	
A.	Application for membership shall be made via application (paper, e-sign, or voice authorization) as provided by Public School Employees. Such application shall include a valid authorization for payroll deduction of State dues. State PSE dues shall be subject to State PSE Bylaws.	
В.	. Current local dues of Public School Employees of Fife shall be three dollars (\$3.00) per month. Such dues shall be collected on a monthly basis. Local dues shall be sent direct the Association. Membership dues are not refundable except where an error resulting in overpayment exists. Free riders do not pay local dues.	
Section 3.	Rights.	
A.	Members shall suffer no impairment of freedom of speech concerning the operations of this organization. Active discussions of organization affairs shall be encouraged and protected within this organization.	
B.	Members shall have the right to fair and democratic elections at all levels of the organization This includes due notice of nominations and elections, equal opportunities for competing candidates, and proper election procedures which shall be specifically set forth.	
C.	C. Members shall have an equal right to run and hold office, except those persons set forth a RCW 41.56.030 Par. 2, a, b and c (attached on last page), and those employees classified either by State statute or appropriate State regulatory agencies as being a "supervisory employee."	
D.	Members shall have the right to a full and clear accounting of all organizational funds. At al levels such accounting shall include, but not be limited to, periodical reports to the membership by appropriate fiscal officers or by independent auditors not otherwise connected with the organization, and a financial audit at least once a year which is made available to all members.	
E.	Members shall have the right to full participation, through discussion and vote, in the decision making processes of the organization and to pertinent information needed for the exercises of this right.

The President shall attempt to provide at least five (5) days notification to all members of any meeting 6

- called. However, said five (5) days notice may be waived by the Board of Trustees provided that every 7
- reasonable effort is employed to notify the membership of the meeting. 8

#### Section 4. 10

- At any meeting of the membership of this organization, each member shall be entitled to one vote. A 11 member must be present to vote - no proxy vote will be allowed. A minimum of seven (7) members
- 12 must be present to constitute a quorum before any organization business may be transacted. 13

#### Section 1. 21

The business and property of this organization shall be managed by a Board of Trustees, except when the 22

#### Section 2. 27

- The Board of Trustees shall be composed of the President(s), Vice President, Secretary, Treasurer, and a 28 representative from each classification, i.e., classification representatives. 29

#### Section 3. 31

The term of office of the trustees of this organization shall be for a period of two (2) years from the date 32 of election, which shall be held at the last meeting of the year. 33

#### 34 Section 4. 35

The Board of Trustees shall hold meetings as the President(s) or the Board shall deem necessary for the 36 competent management of affairs of the organization. 37

- Section 5. 39
- Members of the Board of Trustees shall possess one (1) vote in matters coming before the Board. All 40 voting at meetings of the Board of Trustees shall be by each member present in person and voting by 41
- proxy shall not be allowed. All of the members of the Board of Trustees shall constitute a quorum. 42

#### Section 6. 44

- Any trustee may be removed from office by a two-thirds (2/3) majority vote of the membership at any 45
- regular or special meeting of the membership of the organization. Notice of the proposed removal of the 46
- trustee must be given to the trustee five (5) days prior to the date of the meeting at which the removal is 47



to be voted upon. Such notice to the trustee must state the cause for the proposed removal. Free riders are not eligible to submit a name for removal from office.

Unexcused absences from two (2) consecutive meetings of the Board of Trustees shall be due cause for
removal of the trustee by the Board of Trustees. Removal of a Board member because of excessive
absenteeism shall not require the 2/3 vote of membership.

### 9 <u>Section 8.</u>

Any vacancies occurring on the Board of Trustees by reason of death, resignation or removal shall be filled from the membership at large under the terms of Article VIII, Sections 2 and 3. The term shall be the unexpired term of the trustee whose position has become vacant.

### ARTICLE VIII

#### OFFICERS, CLASSIFICATION REPRESENTATIVES (TRUSTEES): NOMINATIONS AND ELECTIONS

### 21 Section 1.

The officers of this organization shall be a President(s), a Vice President, a Secretary and Treasurer. All officers shall be elected for a term of two (2) consecutive years. President(s) and Secretary to be voted on in even years. Vice president and Treasurer to be voted on in odd years. (See Convention Committee Section 5 Article 1).

### 27 Section 2.

To be eligible for office, a member must be in good standing for one year immediately preceding the election, except in the initial election held in this organization, and must qualify under the provisions of Article V, Section 3-C.

### 32 <u>Section 3.</u>

<sup>33</sup> Officer elections, and ratification of contracts shall be by secret ballot vote. Balloting shall be so

conducted as to afford all members a reasonable opportunity to vote. At least ten (10) working days'

advance notice shall be given the membership prior to the holding of the election.

Section 4.
Nominations may be made by the nominating committee, but whether or not such nominating committee
is used, nominations shall be permitted from the floor at the meeting held to elect officers.

42 Classification representatives shall be elected by members from the classification represented. The term

of office shall be two (2) years. Election shall normally be held at the last general membership meeting

7	The President(s) shall preside at all meetings of the organization and of the Board of Trustees. The		
8 9	President(s) shall supervise all activities of the organization; execute all instruments in its behalf; appoint all special committees of the organization subject to the approval of the Board of Trustees; report		
9 10	periodically to the membership regarding the progress and standing of the organization in regard to the		
11	Presidents' official acts; perform all other duties as prescribed in the Bylaws and perform such other		
12	duties usually inherent in such office.

14	Section 2. Vice President.		
15 16	The Vice President shall act for the President(s) in the Presidents' absence and perform such other acts as the President(s) or Board of Trustees may direct. The Vice President will be the membership		
17	representative and will check with administration about new hires.

19	Section 3. Secretary.		
20	It shall be the duty of the Secretary to keep all records of the organization, the Board of Trustees, and to		
21	perform such other acts as the President and Board of Trustees may direct. Minutes shall be approved by an additional board member, then distributed to all members within two weeks (14 days) following each		
22 23	monthly meeting. Copies of the minutes shall be available at meetings.

25	Section 4. Treasurer.		
26	The Treasurer shall receive and be accountable for all funds and monies belonging to the organization;		
27	pay all obligations incurred by the organization in payment as authorized by the Board of Trustees;		
28 29	maintain bank accounts and depositories designated by the Board of Trustees; and such money shall be withdrawn only by checks signed by the Treasurer and one officer, or by credit/debit card. The Treasurer		
30	shall render periodical financial reports as required by the Board of Trustees or by the membership; and		
31	keep an accurate record of receipts and disbursements; and shall act as custodian of all properties of the		
32	organization. A copy of the financial report will be made available at all meetings.

34	Section 4.1. Check Writing Policies.		
35 36	All officers will have signatures on the bank accounts. Two signatures will be needed to sign checks. Treasurer and Vice President first. Either President(s) or Secretary may sign in		
37	emergencies.

39	Section 5. Classification Representatives.		
40	Representatives are responsible for administrating the Collective Bargaining Agreement, serving on the		
41	Labor/Management Committee as needed, representing member concerns, grievances, and attending disciplinary meetings with District officials. Representatives serve on the Board of Trustees.

6	This organization shall be at all times subject to the provisions of the Articles of Incorporation and
7	Bylaws of the Public School Employees of Washington. Our bylaws will not conflict with the State PSE.

10	This Chapter shall not enter into any collective bargaining agreement, amendment thereto, dispute
12	settlement agreement, grievance settlement agreement, or any other agreement or waiver which affects
13	or pertains to wages, hours or working conditions of the employees in the bargaining unit, nor any
14	agreement which would affect the rights of employees represented by PSE, nor any agreement affecting
15	the scope of any collective bargaining unit, with the District, Employer, or any other entity or agent,
16	unless such agreement is first approved by the Executive Director of Public School Employees of
17	Washington/SEIU Local 1948 or his/her designee, provided decisions of the Executive Director may
18	be appealed to the Board of Directors.

20	<u>Section 3.</u> The latest edition of <b>Robert's Rules of Order</b> , Revised shall be the guide in all cases in which they are
21 22	applicable, and in which they are not inconsistent with the Constitution, Bylaws and special rules of this
22	organization or of the Public School Employees of Washington.

35	A Grievance Committee shall be composed of the Board of Trustees. The Vice President shall chair this
36	committee. This committee shall be responsible to determine if a grievance is valid before a grievance
37	may be submitted for arbitration, per the collective bargaining agreement. The committee chair (vice
38	president) shall report the committee's decision, in writing, to the assigned PSE Field Representative. No
39	free rider shall be eligible to appeal to the state grievance per the state bylaws.

41	Section 2. Negotiating Committee.
42	The negotiating committee shall be composed of the board of trustees. The Negotiating Committee shall
43	be authorized to reject proposals of the District, and shall present recommended proposals to the
44	membership for ratification.
