PREAMBLE**A. NAME**

The name of this chapter shall be Public School Employees of Ocean Beach Transportation and shall be an affiliate of Public School Employees of Washington (PSE), a not-for-profit 501(c)5 labor organization operating under the laws of the State of Washington. This organization was chartered by Public School Employees of Washington on September 26, 2002.

B. MISSION - OUR PURPOSE FOR EXISTING

It is the mission of Public School Employees of Ocean Beach Transportation to work closely with Public School Employees of Washington to support the membership through collective bargaining and the protection of those rights, promote educational enrichment opportunities, encourage membership growth, and provide quality leadership while working closely with the state legislature in an effort to enact laws which will represent the best interest of all classified school employees in the State of Washington.

C. VISION - WHAT WE STRIVE TO ACHIEVE

We will provide service of superior quality and value that best meets the needs of our chapter members. We will achieve that purpose through an organization and working environment which attracts the finest people, fully develops and challenges individual talents, encourages our free and spirited collaboration to drive the organization ahead, and maintains PSE's historic principles of integrity and commitment to do the right thing.

Through the successful pursuit of our commitment, we expect our services, programs, and activities to achieve a leadership position in representing all classified employees. As a result, PSE, our members, PSE employees, the school district in which we work, and the community in which we live will grow and prosper.

ARTICLE I

MEMBERSHIP

Section 1.1. Except as otherwise provided in these bylaws, any person, without regard to race, creed, color, national origin, gender, or political belief, shall be eligible for membership.

Section 1.1.1. Active Member. Any classified school employee who is regularly employed by or for the Ocean Beach School District, and who is a member of Public School Employees of Washington, is eligible for membership in this chapter. A classified employee is one whose position does not require a teaching certificate.

Section 1.1.2. Member In Good Standing. To be eligible to vote and to hold office, a member must be in good standing. To be in good standing, the member shall be employed and current in payment of dues as are required by these bylaws. Any member who is on authorized leave of absence pursuant to the collective bargaining agreement shall retain the right to vote and hold office. Any member who is terminated from employment shall not be eligible to vote or hold office.

ARTICLE II

DUES

Section 2.1. State Dues. State dues shall be paid monthly to the state office of PSE as outlined in the state bylaws.

Section 2.1.1. Chapter Rebates. Dues rebates from the state organization shall be received by the chapter in accordance with the provisions of the state bylaws.

1 **Section 2.2. Local Dues.** Local membership dues shall be \$1.00 per month through payroll
 2 deduction. Local dues shall be paid monthly to the chapter treasurer by the school district. Any
 3 member who is on an authorized leave of absence pursuant to the collective bargaining agreement
 4 may have local dues collection suspended upon approval by the chapter Board of Trustees.

5
 6 **Section 2.3. Refunds.** Membership dues are not refundable except where an error resulting in an
 7 overpayment exists.

 11 **ARTICLE III**
 12

13 **GOVERNANCE AND OPERATIONS**
 14

15 **Section 3.1.** PSE shall be governed by a representative form of government.
 16

17 **Section 3.2.** Members shall suffer no impairment of freedom of speech concerning the operations of
 18 this organization. Active discussions of organization affairs shall be encouraged and protected within
 19 this organization.
 20

21 **Section 3.3.** Members shall have the right to a full and clear accounting of all organizational funds.
 22 At all levels such accounting shall include, but not be limited to, periodical reports to the membership
 23 by appropriate fiscal officers or by independent auditors not otherwise connected with the
 24 organization, and a financial audit at least once a year which is made available to all members.
 25

26 **Section 3.4.** Members shall have the right to full participation, through discussion and vote, in the
 27 decision making processes of the organization and to pertinent information needed for the exercises
 28 of this right.
 29

30 **Section 3.5. GOVERNING BODY.**
 31

32 **Section 3.5.1. Board of Trustees.** Except when general meetings of the chapter are in session,
 33 the business and property of this chapter shall be managed by a Board of Trustees. The authority to
 34 govern and act on behalf of the membership is vested in the elected Board of Trustees who shall
 35 decide all matters affecting the purposes, aims and means of accomplishing the purposes of this
 36 chapter, not specifically provided for in these bylaws or by action of the members at a regular or
 37 special meeting.
 38

39 **Section 3.5.2. PSE Field Staff.** PSE field staff shall work closely with the chapter in an
 40 advisory position. All decisions governing the business of the local chapter shall be the sole
 41 responsibility of the elected officials and membership of the chapter.

1 **Section 3.6. OPERATING PRINCIPLES.** In order to provide the chapter with the highest quality
2 direction and management possible, the following operating principles shall guide the Board of
3 Trustees.
4

5 **Section 3.6.1. Board/Membership Relationships.** A positive, constructive, cooperative
6 relationship between the Board of Trustees and the membership is essential to achieving the mission
7 and vision of the organization. Therefore, the board and membership will conduct themselves in a
8 way that promotes mutual trust, demonstrates respect for individual dignity, and displays
9 professionalism. The board shall utilize positive conflict resolution methods and maintain open,
10 honest lines of communication that respect an appropriate chain of command within the chapter.
11

12 **Section 3.6.2. Media.** The president, or his/her designee, is the primary spokesperson for the
13 chapter. Media inquiries to individual board members about matters of chapter concern should be
14 referred to the chapter president. Inquiries about a position of PSE on any matter of statewide
15 concern or specific legislation should be referred to the executive director at state headquarters.

19 ARTICLE IV

20 **MEETINGS**

21
22
23 **Section 4.1.** General membership meetings of this chapter shall be held at least four (4) times during
24 the school year at a time and place to be fixed by the membership or the Board of Trustees.
25

26 **Section 4.2.** Special meetings may be called by the president, the Board of Trustees, or by petition
27 filed with the president and signed by twenty percent (20%) of the members in good standing of this
28 chapter.
29

30 **Section 4.3.** The president shall provide at least five (5) working days notification to all members of
31 any meeting called. However, said five (5) days notice may be waived by the Board of Trustees
32 provided that every reasonable effort is employed to notify the membership of the meeting.
33

34 **Section 4.4.** At any meeting of the membership of this chapter, each member in good standing
35 present shall be entitled to one vote. A member must be present to vote, unless excused by the Board
36 of Trustees. No proxy vote will be allowed. A minimum of officers in attendance plus six (6)
37 members must be present to constitute a quorum before any chapter business may be transacted.
38

39 **Section 4.5. Board of Trustees Meetings.** Meetings of the Board of Trustees shall be called at the
40 discretion of the president. Meetings may also be called upon motion of a majority of the members of
41 the Board of Trustees to the president. A majority of the members of the Board of Trustees shall
42 constitute a quorum.
43

44 **Section 4.6.** The latest edition of Robert's Rules of Order shall be a reference guide on conducting
45 business at meetings; provided that they shall be superseded by the bylaws and special rules of this
46 chapter or of Public School Employees of Washington.

ARTICLE V

BOARD OF TRUSTEES

Section 5.1. The Board of Trustees shall be composed of the president, vice president, secretary, treasurer, and a unit representative (herein known as a trustee) elected by the unit from each classification of employees of the school district if represented by the local Public School Employees organization.

Section 5.2. The term of office shall be for a period of two (2) years, or until their successors are elected.

Section 5.3. The Board of Trustees shall hold regular meetings and such special meetings as the president or the board shall deem necessary for the competent management of affairs of the chapter.

Section 5.4. Each member of the Board of Trustees shall possess one (1) vote in matters coming before the board. All voting at meetings of the Board of Trustees shall be by each member present in person, and voting by proxy shall not be allowed. A majority of the members of the Board of Trustees shall constitute a quorum.

Section 5.5. Duties.

Section 5.5.1. President. The president shall preside at all meetings of the chapter and of the Board of Trustees. The president shall be made aware of, and supervise all activities of the chapter; execute all instruments in its behalf; and work with PSE field staff, with the advice and consent of the Board of Trustees, to achieve the mission, vision, goals, and objectives of the chapter. The president shall appoint all special committees not otherwise provided for in the bylaws of the chapter, subject to the approval of the Board of Trustees, and serve as an ex-officio member of all committees. The president shall report periodically to the membership regarding the progress and standing of the chapter in regard to the president’s official acts; and perform all other duties of the office.

Section 5.5.2. Vice President. The vice president shall provide such assistance to the president as requested; serve as chairperson of the grievance committee; shall, in the absence of the president, perform duties of that office; and in the case of permanent disability or resignation of the president, shall succeed to that office for the unexpired portion of the current term of office.

Section 5.5.3. Secretary. The secretary shall ensure that the minutes of general membership meetings and Board of Trustee meetings are duly recorded. It shall be the duty of the secretary to keep all records of the chapter, the Board of Trustees, and to perform such other official functions as the president and Board of Trustees may direct.

1 **Section 6.6.** Members of the Board of Trustees shall be elected by secret ballot vote, and the
2 balloting shall be so conducted as to afford all members a reasonable opportunity to vote. At least
3 five (5) days advance notice shall be given the membership prior to the holding of the election.
4

5 **Section 6.6.1.** All members of the chapter shall be eligible to vote for the positions of president,
6 vice president, secretary, and treasurer. In the election of a trustee, only members in the classification
7 of employees that the trustee will represent shall be allowed to vote.
8

9 **Section 6.7.** Every member of the Board of Trustees shall, upon assuming office, subscribe to the
10 obligations contained in these bylaws.
11

12 **Section 6.8.** Any member of the Board of Trustees may be removed from office by a two-thirds (2/3)
13 vote of the membership at any regular or special meeting of the chapter. Written notice of the
14 proposed removal must be given to the Board of Trustee member at least five (5) working days prior
15 to the date of the meeting at which the removal is to be voted upon. Such notice must state the cause
16 for the proposed removal.
17

18 **Section 6.9.** Unexcused absences from three (3) consecutive meetings of the Board of Trustees shall
19 be due cause for removal of the member by the Board of Trustees. Removal of a board member
20 because of excessive absenteeism shall not require the 2/3 vote of the membership.
21

22 **Section 6.10.** A vacancy in any position, except that of president, shall be filled by the Board of
23 Trustees in accordance with the procedures set forth below:
24

25 **Section 6.10.1.** In the event the president cannot serve the remainder of his/her current term,
26 the vice president shall serve as president for the completion of the term.
27

28 **Section 6.10.2.** In the event of a vacancy in the office of vice president, secretary, or treasurer,
29 all members shall be notified of the vacancy and nominations solicited for the position. Nominations
30 shall be accepted for a period of twenty (20) calendar days following the notification to members.
31 The president, at his/her discretion, may either call a special meeting of the Board of Trustees, or act
32 upon the vacancy at the next regularly scheduled board meeting. Each candidate for the position may
33 submit a letter, or have three (3) minutes to address the board prior to the vote to describe their
34 qualifications and reasons they are seeking the position.
35

36 **Section 6.10.3.** Any other vacancy shall be filled only for the remainder of the term in which
37 the vacancy occurs; provided, however, that when vacancies occur in the office of trustee, the
38 president shall direct that a classification meeting be held and that the classification elect a successor
39 for the remainder of the vacant term. Election of the successor must be by majority vote. In the
40 event that more than two candidates run for the office, the candidate with the lowest vote total will be
41 dropped from the ballot after each round of voting until one candidate receives a majority of the votes
42 cast.

ARTICLE VII

MISCELLANEOUS PROVISIONS

Section 7.1. Local chapters shall adopt bylaws that do not conflict with PSE state bylaws. State bylaws shall always supersede local bylaws where conflict exists.

Section 7.2. This chapter shall send to the PSE state office a list of names and addresses of its Board of Trustees and members, together with other information required by PSE and shall notify PSE of all changes in board members, members, and addresses.

Section 7.3. This chapter shall not enter into any collective bargaining agreement, amendment thereto, dispute settlement agreement, grievance settlement agreement, or any other agreement or waiver which affects or pertains to wages, hours or working conditions of the employees in the bargaining unit, nor any agreement which would affect the rights of employees represented by PSE, nor any agreement affecting the scope of any collective bargaining unit, with the district, employer, or other entity or agent, unless such agreement is first reviewed and approved by the executive director of Public School Employees of Washington or his/her designee, provided decisions of the executive director may be appealed to the Board of Directors.

Section 7.3.1. Original signed copies of all documents pertaining to issues outlined in Section 7.3 shall be submitted to the regional office, who will then forward the original to state headquarters after appropriate copies have been made.

ARTICLE VIII

COMMITTEES AND DELEGATES

Section 8.1. Grievance Committee. The grievance committee shall be composed of the vice president and at least two other members of the chapter.

Section 8.2. Negotiating Committee. The Board of Trustees shall serve as the negotiating committee and shall work with the PSE field representative in developing proposals and negotiating agreements.

Section 8.3. Annual Convention Delegates. Delegates shall be elected by secret ballot. Approved expenses incurred by elected delegates attending the annual convention shall be paid by the chapter or in accordance with appropriate provisions of PSE state bylaws.

Section 8.4. Audit Committee. An audit committee shall be selected by the Board of Trustees to audit the financial records of the chapter.

Section 8.5. Other Or Special Committees. The Board of Trustees shall designate such special committees as they determine necessary in the carrying out of the objectives and purposes of this chapter.

ARTICLE IX

AMENDMENTS

Section 9.1. These bylaws may be amended by a majority vote of the membership at any regular or special meeting thereof; providing, that notice of the intent to amend any specific provision be given to the members of the membership at least five (5) working days prior to the meeting at which said vote is to be taken.
