

2      **P R E A M B L E**

3  
4      **A. NAME**

5  
6      The name of this chapter shall be Public School Employees of Orcas Island and shall be an affiliate  
7      of Public School Employees of Washington (PSE), a not-for-profit 501(c)5 labor organization  
8      operating under the laws of the State of Washington. This Chapter was chartered by Public School  
9      Employees of Washington on July 7, 2004.

10  
11     **B. MISSION - OUR PURPOSE FOR EXISTING**

12  
13     It is the mission of Public School Employees of Orcas Island to work closely with Public School  
14     Employees of Washington to support the membership through collective bargaining and the  
15     protection of those rights, promote educational enrichment opportunities, encourage membership  
16     growth, and provide quality leadership while working closely with the state legislature in an effort to  
17     enact laws which will represent the best interest of all classified school employees in the state of  
18     Washington.

20     **C. VISION - WHAT WE STRIVE TO ACHIEVE**

21  
22     We will provide service of superior quality and value that best meets the needs of our chapter  
23     members. We will achieve that purpose through an organization and working environment which  
24     attracts the finest people, fully develops and challenges individual talents, encourages our free and  
25     spirited collaboration to drive the organization ahead, and maintains PSE's historic principles of  
26     integrity and commitment to do the right thing.

27  
28     Through the successful pursuit of our commitment, we expect our services, programs, and activities  
29     to achieve a leadership position in representing all classified employees. As a result, PSE, our  
30     members, PSE employees, the school district in which we work, and the community in which we  
31     live will grow and prosper.

14           **A R T I C L E    I**

15           **MEMBERSHIP**

18           **Section 1.1.** Except as otherwise provided in these bylaws, any person, without regard to race, creed,  
19           color, national origin, sex, or political belief, shall be eligible for membership.

21           **Section 1.1.1. Active Member.** Any classified school employee who is regularly employed by or for  
22           the Orcas Island School District, and who is a member of Public School Employees of Washington, is  
23           eligible for membership in this chapter. A classified employee is one whose position does not require a  
24           teaching certificate.

26           **Section 1.1.2. Member in Good Standing.** To be eligible to vote and to hold office, a member must be  
27           in good standing. To be in good standing, the member shall be employed and current in payment of dues  
28           as are required by these bylaws. Any member who is on authorized leave of absence pursuant to the  
29           Collective Bargaining Agreement, shall retain the right to vote and hold office. Any member who is  
30           terminated from employment shall not be eligible to vote or hold office.

34           **A R T I C L E    II**

36           **DUES**

38           **Section 2.1. State Dues.** State dues shall be paid monthly to the state office of PSE as outlined in the  
39           state bylaws.

41           **Section 2.1.1. Chapter Rebates.** Dues rebates from the state organization shall be received by the  
42           chapter in accordance with the provisions of the state bylaws.

44           **Section 2.2. Local Dues.** Local membership dues shall be twelve dollars (\$12.00) per year, deducted  
45           out of the member’s October paycheck. New employees will have dues prorated from month of hire and  
46           this amount will be deducted from the first paycheck issued. Local dues shall be paid to the chapter  
47           treasurer by the school district. Any member who is on an authorized leave of absence pursuant to the

<sup>1</sup> Collective Bargaining Agreement may have local dues collection suspended upon approval by the  
<sup>2</sup> Chapter Board of Trustees.

**4      Section 2.3. Refunds.** Membership dues are not refundable except where an error resulting in an

**5      overpayment exists.**

### ARTICLE III

## GOVERNANCE AND OPERATIONS

**Section 3.1.** PSE shall be governed by a representative form of government.

**Section 3.2.** Members shall suffer no impairment of freedom of speech concerning the operations of this organization. Active discussions of organization affairs shall be encouraged and protected within this organization.

**Section 3.3.** Members shall have the right to a full and clear accounting of all organizational funds. At all levels such accounting shall include, but not be limited to, periodic reports to the membership by appropriate fiscal officers or by independent auditors not otherwise connected with the organization, and a financial audit at least once a year which is made available to all members.

**Section 3.4.** Members shall have the right to full participation, through discussion and vote, in the decision making processes of the organization and to pertinent information needed for the exercises of this right.

### **Section 3.5. GOVERNING BODY**

**Section 3.5.1. Board of Trustees.** Except when general meetings of the chapter are in session, the business and property of this chapter shall be managed by a Board of Trustees. The authority to govern and act on behalf of the membership is vested in the elected Board of Trustees who shall decide all matters affecting the purposes, aims and means of accomplishing the purposes of this chapter, not specifically provided for in these bylaws or by action of the members at a regular or special meeting.

**Section 3.5.2. PSE Field Staff.** PSE field staff shall work closely with the chapter in an advisory position. All decisions governing the business of the local chapter shall be the sole responsibility of the elected officials and membership of the chapter.

**Section 3.6. Operating Principles.** In order to provide the chapter with the highest quality direction and management possible, the following operating principles shall guide the Board of Trustees.

**Section 3.6.1. Board/Membership Relationships.** A positive, constructive, cooperative relationship between the Board of Trustees and the membership is essential to achieving the mission and vision of the organization. Therefore, the board and membership will conduct themselves in a way that promotes mutual trust, demonstrates respect for individual dignity, and displays professionalism. The board shall utilize positive conflict resolution methods and

1 maintain open, honest lines of communication that respect an appropriate chain of command  
2 within the chapter.

3  
4 **Section 3.6.2. Media.** The president, or his/her designee, is the primary spokesperson for the  
5 chapter. Media inquiries to individual board members about matters of chapter concern should  
6 be referred to the chapter president. Inquiries about a position of PSE on any matter of statewide  
7 concern or specific legislation should be referred to the executive director at state headquarters.

11 **A R T I C L E   I V**

12 **MEETINGS**

13  
14 **Section 4.1.** General membership meetings of this chapter shall be held at least four (4) times annually  
15 at a time and place to be fixed by the membership or the Board of Trustees.

16  
17 **Section 4.2.** Special meetings may be called by the president, the Board of Trustees, or by petition filed  
18 with the president and signed by twenty percent (20%) of the members in good standing of this chapter.

19  
20 **Section 4.3.** The president shall provide at least five (5) days notification to all members of any meeting  
21 called. However, said five (5) days notice may be waived by the Board of Trustees provided that every  
22 reasonable effort is employed to notify the membership of the meeting.

23  
24 **Section 4.4.** At any meeting of the membership of this chapter, each member in good standing present  
25 shall be entitled to one vote. A member must be present to vote -- no proxy vote will be allowed. A  
26 minimum of five (5) members must be present to constitute a quorum before any chapter business may  
27 be transacted.

28  
29 **Section 4.5. Board of Trustees Meetings.** Meetings of the Board of Trustees shall be called at the  
30 discretion of the president. Meetings may also be called upon motion of a majority of the members of  
31 the Board of Trustees to the President. A majority of the members of the Board of Trustees shall  
32 constitute a quorum.

33  
34 **Section 4.6.** The rules contained in the current edition of Robert's Rules of Order Newly Revised shall  
35 govern this chapter in all cases to which they are applicable and in which they are not inconsistent with  
36 the PSE state bylaws, these bylaws and with any special rules of order this chapter may adopt.

41 **A R T I C L E   V**

42  
43 **BOARD OF TRUSTEES**

44  
45 **Section 5.1.** The Board of Trustees shall be composed of the president, vice president, co-  
46 secretary/treasurers, membership officer, and a unit representative (herein known as a trustee) elected by  
47 the unit from each classification of employees of the school district if represented by the local Public  
48 School Employees organization.

1  
2 **Section 5.2.** The term of office shall be for a minimum of one (1) year.  
3

4 **Section 5.3.** The Board of Trustees shall hold regular meetings, and such special meetings as the  
5 president or the board shall deem necessary for the competent management of affairs of the Chapter.  
6

7 **Section 5.4.** Each member of the Board of Trustees shall possess one (1) vote in matters coming before  
8 the board. All voting at meetings of the Board of Trustees shall be by each member present in person,  
9 and voting by proxy shall not be allowed. A majority of the members of the Board of Trustees shall  
10 constitute a quorum.  
11

12 **Section 5.5. Duties.**  
13

14 **Section 5.5.1. President.** The president shall preside at all meetings of the chapter and of the  
15 Board of Trustees. The president shall be made aware of, and supervise all activities of the  
16 chapter; execute all instruments in its behalf; and work with PSE field staff, with the advice and  
17 consent of the Board of Trustees, to achieve the mission, vision, goals, and objectives of the  
18 chapter. The president shall appoint all special committees not otherwise provided for in the  
19 bylaws of the chapter, subject to the approval of the Board of Trustees, and serve as an ex-officio  
20 member of all committees. The president shall report periodically to the membership regarding  
21 the progress and standing of the chapter in regard to the president's official acts; and perform all  
22 other duties of the office.  
23

24 **Section 5.5.2. Vice President.** The vice president shall provide such assistance to the president  
25 as requested; serve as chairperson of the Grievance Committee; shall, in the absence of the  
26 president, perform duties of that office; and in the case of permanent disability or resignation of  
27 the president, shall succeed to that office for the unexpired portion of the current term of office.  
28

29 **Section 5.5.3. Co-Secretary/Treasurers.** The co-secretary/treasurers shall ensure that the  
30 minutes of general membership meetings and Board of Trustee meetings are duly recorded. It  
31 shall be the duty of the co-secretary/treasurers to keep all records of the chapter, the Board of  
32 Trustees, and to perform such other official functions as the president and Board of Trustees may  
33 direct. The co-secretary/treasurers shall receive and be accountable for all funds and monies  
34 belonging to the chapter; pay all obligations incurred by the chapter as authorized by the Board  
35 of Trustees; keep an accurate record of receipts and disbursements; and maintain bank accounts  
36 and depositories designated by the Board of Trustees. Such money shall be withdrawn only by  
37 checks signed by the president and/or vice president and one of the co-secretary/treasurers. The  
38 co-secretary/treasurers shall render periodic financial reports as required by the Board of  
39 Trustees, the membership, or Public School Employees of Washington to ensure that the chapter  
40 is in compliance with all laws and regulations required by the Internal Revenue Service and the  
41 Department of Labor. The fiscal year for all financial reports shall be from September 1 to  
42 August 31 of the following year, inclusive. The co-secretary/treasurers shall act as custodian of  
43 all properties of the chapter.  
44

45 **Section 5.5.4. Membership Officer.** It shall be the duty of the membership officer to maintain  
46 a current and accurate list of members of the chapter in coordination with the membership  
47 information section at PSE state headquarters; ensure that all members are paying dues; render

periodic membership reports as required by Public School Employees of Washington; and perform such other official functions as the president and Board of Trustees may direct.

**Section 5.5.5. Trustee.** A trustee shall represent the classification of employees which elected them and express to the Board of Trustees the needs, desires, and concerns of the members in their classification. They will be responsible, along with the Grievance Committee, in advising an employee about their contractual rights.

## ARTICLE VI

## **ELECTIONS, FILLING OF VACANCIES, AND RECALL PROCEDURES**

**Section 6.1.** Members shall have the right to fair and democratic elections at all levels of the chapter. This includes ten (10) working days notice of nominations and elections, and equal opportunities for competing candidates to state their qualifications and reasons for seeking office to the chapter membership. Elections shall be conducted by secret written ballot and certified by the chapter co-secretary/treasurers.

**Section 6.2.** Members shall have an equal right to run and hold office, except those persons set forth in RCW 41.56.030 Par. 2, a, b and c, and those employees classified either by state statute or appropriate state regulatory agencies as being a “supervisory employee.”

**Section 6.3.** Nominations for chapter officers will be made in April and the elections shall be held during the month of May. Terms of office shall be from September 1 through August 31.

**Section 6.4.** Nominations may be made by the nominating committee, but whether or not such nominating committee is used, nominations shall be permitted from the floor at the meeting held for the election.

**Section 6.5.** To be eligible, a member must be in good standing for six (6) months immediately preceding the election.

**Section 6.6.** Members of the Board of Trustees shall be elected by secret ballot vote, and the balloting shall be so conducted as to afford all members a reasonable opportunity to vote. At least ten (10) working days advance notice shall be given the membership prior to the holding of the election.

**Section 6.6.1.** All members of the Chapter shall be eligible to vote for the positions of President, Vice President, Co-Secretary/Treasurers, and Membership Officer. In the election of a Trustee, only members in the classification of employees that the Trustee will represent shall be allowed to vote.

**Section 6.7.** Every member of the Board of Trustees shall, upon assuming office, subscribe to the obligations contained in these bylaws.

**Section 6.8.** Any member of the Board of Trustees may be removed from office by a two-thirds (2/3) vote of the membership at any regular or special meeting of the chapter. Written notice of the proposed

1 removal must be given to the Board of Trustee member at least five (5) working days prior to the date of  
2 the meeting at which the removal is to be voted upon. Such notice must state the cause for the proposed  
3 removal.

4  
5 **Section 6.9.** Unexcused absences from three (3) consecutive meetings of the Board of Trustees shall be  
6 due cause for removal of the member by the Board of Trustees. Removal of a board member because of  
7 excessive absenteeism shall not require the 2/3 vote of the membership.

8  
9 **Section 6.10.** A vacancy in any position, except that of president, shall be filled by the Board of  
10 Trustees in accordance with the procedures set forth below:

11  
12 **Section 6.10.1.** In the event the president cannot serve the remainder of his/her current term, the  
13 vice president shall serve as president for the completion of the term.

14  
15 **Section 6.10.2.** In the event of a vacancy in the office of vice president, co-secretary/treasurers,  
16 or membership officer, all members shall be notified of the vacancy and nominations solicited for  
17 the position. Nominations shall be accepted for a period of twenty (20) calendar days following  
18 the notification to members. The president, at his/her discretion, may either call a special  
19 meeting of the Board of Trustees, or act upon the vacancy at the next regularly scheduled board  
20 meeting. Each candidate for the position may submit a letter or have three (3) minutes to address  
21 the board prior to the vote to describe their qualifications and reasons they are seeking the  
22 position.

23  
24 **Section 6.10.3.** Any other vacancy shall be filled only for the remainder of the term in which the  
25 vacancy occurs; provided, however, that when vacancies occur in the office of trustee, the  
26 president shall direct that a classification meeting be held and that the classification elect a  
27 successor for the remainder of the vacant term. Election of the successor must be by majority  
28 vote. In the event that more than two (2) candidates run for the office, the candidate with the  
29 lowest vote total will be dropped from the ballot after each round of voting until one (1)  
30 candidate receives a majority of the votes cast.

31  
32 **Section 6.11.** In the event of a prolonged natural disaster, pandemic, or other "Act of God" which  
33 prevents the membership from meeting in person for the purposes of voting for union officers through  
34 secret ballot for an extended period of time, the following process for appointment of interim local union  
35 officers to fill positions shall be utilized:

37 1) If an election cannot be held prior to the conclusion of the current school year, all officers who  
38 are currently in office and wish to continue to serve shall be considered "interim" officers until  
39 such time as an election can be safely held, which time shall not exceed six months;  
40 2) In the event that the President wishes to step down from the presidency, and or is no longer  
41 eligible to serve as President, the Vice-president shall serve as the interim President until such  
42 time as a secret ballot election can occur, which time shall not exceed six months;  
43 3) In the event that any officer or Board Member (other than the President) no longer wishes to  
44 serve or is no longer eligible to serve, the Executive Board shall appoint a willing member to  
45 serve as the interim officer until such time as a secret ballot election can occur, which time shall  
46 not exceed six months.



## ARTICLE VII

## **MISCELLANEOUS PROVISIONS**

**Section 7.1.** Local chapters shall adopt bylaws that do not conflict with PSE state bylaws. State bylaws shall always supersede local bylaws where conflict exists.

**Section 7.2.** This chapter shall send to the PSE state office a list of names and addresses of its Board of Trustees and members, together with other information required by PSE and shall notify PSE of all changes in board members, members, and addresses.

**Section 7.3.** This chapter shall not enter into any collective bargaining agreement, amendment thereto, dispute settlement agreement, grievance settlement agreement, or any other agreement or waiver which affects or pertains to wages, hours or working conditions of the employees in the bargaining unit, nor any agreement which would affect the rights of employees represented by PSE, nor any agreement affecting the scope of any collective bargaining unit, with the District, Employer, or other entity or agent, unless such agreement is first reviewed and approved by the Executive Director of Public School Employees of Washington or his/her designee, provided decisions of the executive director may be appealed to the Board of Directors.

**Section 7.3.1.** Original signed copies of all documents pertaining to issues outlined in Section 7.3 shall be submitted to the regional service center, which will then forward the original to state headquarters after appropriate copies have been made.

## ARTICLE VIII

## COMMITTEES AND DELEGATES

**Section 8.1. Grievance Committee.** A Grievance Committee shall be composed of the vice president and at least one unit representative from each classification of employees in the chapter; and shall be responsible for advising members of their rights as outlined in the state bylaws, Article XIV, State Grievance Panel.

**Section 8.2. Negotiating Committee.** A Negotiating Committee shall consist of a representative elected from each classification of employees represented by this bargaining unit and shall work with the PSE field representative in developing proposals and negotiating agreements.

**Section 8.3. Labor/Management Committee.** The Labor/Management Committee shall consist of the chapter president and up to three (3) other members and will meet with management on a mutually agreeable basis to maintain the contract language and discuss employee and work-related issues per contract language in Article VII, Section 7.2.

**Section 8.4. Annual Convention Delegates.** Delegates shall be elected by secret ballot. Approved expenses incurred by elected delegates attending the annual convention shall be paid by the chapter or in accordance with appropriate provisions of PSE State Bylaws.

**Section 8.5. Other or Special Committees.** The Board of Trustees shall designate such special committees as they determine necessary in the carrying out of the objectives and purposes of this chapter.

## ARTICLE IX

## AMENDMENTS

11 **Section 9.1.** These bylaws may be amended by a majority vote of the membership at any general  
12 membership meeting thereof; providing, that notice of the intent to amend any specific provision be  
13 given to the membership at least five (5) working days prior to the meeting at which said vote is to be  
14 taken.
