10 17 18 19 20	We are under a solemn obligation to represent the members of this organization forcefully and effectively in negotiations with the management of the Pe Ell School District #301 and to conduct internal organizational affairs according to democratic standards.

27 28 29 30	The name of this organization shall be the Public School Employees of Pe Ell School District #301.

 33 34 35 36 37 38 	This local organization shall be affiliated with and be a chapter of the Public School Employees of Washington / SEIU Local 1948. This organization was chartered by Public School Employees of Washington in June of 1969.

5 6	A.	To carry out and assist on a local basis the objectives and purposes of the Public School Employees of Washington / SEIU Local 1948.
7 8 9	B.	To promote the organization of Public School Employees in the Pe Ell School District #301.

To promote the welfare of the membership and the classified employees of the Pe Ell School District #301, and to provide a voice in the determination of the terms and conditions of employment. We are committed to the process of collective bargaining as a desirable, democratic and effective method to achieve this.

To promote and provide systematic and effective employee management through collective bargaining; to confer and negotiate in good faith, with respect to grievance procedures and collective negotiations on personnel matters, including wages, hours and working conditions, vacations, holidays and other conditions of employment for the classified employees of Pe Ell School District #301.
21 22 23 24	E.	Both as members and as citizens, we shall also employ available legislative and political action to establish adequate financial provisions for the improvement of public school education and equitable consideration for the classified school employees from the State Legislators.

43	B.	Member In Good Standing. To be eligible to vote and to hold office, a member must be in
44	21	good standing. To be in good standing, the member shall be employed and current in payment
45		of dues as are required by these bylaws. Any member who is on authorized leave of absence
46		pursuant to the Collective Bargaining Agreement shall retain the right to vote and hold office.

- A. <u>State Dues.</u> State dues shall be paid monthly through payroll deduction to the state office of Public School Employees of Washington / SEIU Local 1948 as outlined in the state bylaws.
- B. <u>Local Dues</u>. Local membership dues of this organization shall be twenty-four dollars (\$24.00) per year. Local membership dues shall be paid each October by payroll deduction and will be submitted to the Secretary-Treasurer of Public School Employees of Pe Ell; provided, however, that for the 2014-2015 school year local dues will be deducted in March.
- C. Membership dues are not refundable except where an error resulting in an overpayment exists.

13 Section 5.3. Rights.

- A. Members shall suffer no impairment of freedom of speech concerning the operations of this organization. Active discussions of organization affairs shall be encouraged and protected within this organization.
- B. Members shall have the right to fair and democratic elections at all levels of the organization. This includes due notice of nominations and elections, equal opportunities for competing candidates, and proper election procedures which shall be specifically set forth.
- C. Members shall have an equal right to run and hold office, except those persons set forth in RCW 41.56.030 Par. 2, a, b, and c; and those employees classified either by State statute or appropriate State regulatory agencies as being a "supervisory employee."
 - D. Members shall have the right to a full and clear accounting of all organizational funds. At all levels such accounting shall include, but not be limited to, periodical reports to the membership by appropriate fiscal officers or by independent auditors not otherwise connected with the organization, and a financial audit at least once a year which is made available to all members.
 - E. Members shall have the right to full participation, through discussion and vote, in the decisionmaking processes of the organization and to pertinent information needed for the exercises of this right.

ARTICLE VI

MEETINGS

42 Section 6.1.

- General membership meetings of this organization shall be held at least four (4) times annually at a
 time and place to be fixed by the membership or the Board of Trustees.

- 47 Special meetings may be called by the President, the Board of Trustees, or by petition filed with the
- 48 President and signed by twenty percent (20%) of the members of this organization.

- 2 The President shall provide at least five (5) days notification to all members of any meeting called.
- However, said five (5) days notice may be waived by the Board of Trustees provided that every 3
- reasonable effort is employed to notify the membership of the meeting. 4

5 Section 6.4. 6

- At any meeting of the membership of this organization, each member present shall be entitled to one 7
- 8 (1) vote. A member must be present to vote - no proxy vote will be allowed. A minimum of six (6)
- members must be present to constitute a quorum before any organization business may be transacted. 9

16 Section 7.1. 17

- The business and property of this organization shall be managed by a Board of Trustees, except when 18 the meetings of the organization are in session. All matters affecting the purposes, aims and means of 19 accomplishing the purposes of this organization, not specifically provided for in these Bylaws or by 20
- action of the members at a regular or special meeting shall be decided by the Board of Trustees. 21

22 <u>Section 7.2.</u> 23

- The Board of Trustees shall be composed of the President, Vice President, Secretary, Treasurer and a 24 unit representative elected by the unit from each of the following classifications of employees of the 25 school district if represented by the local Public School Employees organization. 26

- Each member of the Board of Trustees shall possess one (1) vote in matters coming before the Board. 2
- All voting at meetings of the Board of Trustees shall be by each member present in person, and voting 3

- 5 quorum.

8 Any trustee may be removed from office by a two-thirds (2/3) majority vote of the membership at any

- regular or special meeting of the membership of the organization. Notice of the proposed removal of 9
- the trustee must be given to the trustee five (5) days prior to the date of the meeting at which the 10 removal is to be voted upon. Such notice to the trustee must state the cause for the proposed removal.

Unexcused absences from two (2) consecutive meetings of the Board of Trustees shall be due cause for 14 removal of the trustee by the Board of Trustees. Removal of a Board member because of excessive 15 absenteeism shall not require the 2/3 vote of membership. 16

Section 7.8. 18

Any vacancies occurring on the Board of Trustees by reason of death, resignation or removal shall be 19 filled by the remaining trustees. In the event that such trustee is an officer, such selection shall be from 20 the membership at large. All other trustees' vacancies shall be filled from the classification of which 21 they are representatives. Such appointee shall serve during the unexpired term of the trustee whose 22 position has become vacant. 23

ARTICLE VIII

OFFICERS, NOMINATIONS AND ELECTIONS

Section 8.1. 31

The officers of this organization shall be a President, a Vice President, a Secretary, and Treasurer. All 32 officers shall be elected for a term of one (1) year. 33

Nominations may be made by the nominating committee, but whether or not such nominating 36

committee is used, nominations shall be permitted from the floor at the meeting held to elect officers. 37

To be eligible for office, a member must be in good standing for one (1) year immediately preceding 40 the election and must qualify under the provisions of Article V, Section 5.3-C. 41

43 Section 8.4.

Officers shall be elected by secret ballot vote, and the balloting shall be so conducted as to afford all 44

members a reasonable opportunity to vote. At least ten (10) days advance notice shall be given the 45

membership prior to the holding of the election. 46

withdrawn only by checks signed by the President and/or Vice President and the Treasurer; and shall

render periodical financial reports as required by the Board of Trustees or by the membership; and

keep an accurate record of receipts and disbursements; and shall act as custodian of all properties of
